TOWN OF POMPEY TOWN BOARD MINUTES

The Town Board of the Town of Pompey held a Special Meeting on December 28, 2020. It was held via video conferencing, as permitted by the NYS Open Meetings Law and Executive Order 202.1. This is based upon notices and health advisories issued by Federal, State, and Local officials related to the COVID-19 virus. Board members remotely attended the meeting by connecting to video conference from an electronic device. For the public's viewing, the video conferencing meeting was hosted via zoom. There were still some technical difficulties, so it was not livestreamed on Facebook, however all residents were given the zoom link if they wanted to participate in the meeting.

The following remotely attended: Supervisor Renee Rotondo, Councilors Judy McElhannon, Ann Christmas, Carl Dennis; Highway Superintendent Tom Purcell; Accountant 1 Tom Chartrand; Town Attorney Tim Frateschi; Assessor Larry Fitts, Town Clerk Nikki Reid; and Zoom Host Veronica Hotaling.

Supervisor Rotondo called the meeting to order at 6:32 p.m. followed by the Pledge of Allegiance.

A moment of silence was held for Jim McDermott, a retired Highway employee, who passed away on December 8, 2020. He will be sorely missed. To Barb and his family, please know that our thoughts are with you.

R-194-20 Motion by Christmas, seconded by Dennis to approve the payment of General Fund Abstract Nos. 414-428, totaling \$6,354.44; Highway Fund Abstract Nos. 210-228, totaling \$55,362.24. All in favor. Motion carried.

Supervisor Rotondo explained the purpose of holding the special meeting is for the consideration of a resolution to waive renewal requirement for 2021 tax exemption for low income seniors and low income individuals with disabilities. The reason for this is to keep seniors and individuals with disabilities safe from traveling to the Town Hall due to the COVID-19 pandemic. Town Attorney Tim Frateschi stated that if they do decide to fill out a renewal form, then this resolution also authorizes the form to be processed by the Assessor. Town Assessor Larry Fitts stated that he was originally opposed to this resolution for fear of confusing people. This renewal form gets sent out every year and seniors and individuals with disabilities will be expecting it to come in the mail. However, due to the pandemic, Larry agrees that this is a good idea, and he thinks the resolution should be passed. He advised that a letter that explains the resolution will be mailed to all seniors and individuals with disabilities, as well as posted on the website and the Town of Pompey's Facebook page. A copy will also be posted at the Town Hall. There are approximately 138 property owners that have this exemption. Supervisor Rotondo reviewed the letter and she said it's very simple and straightforward.

WHEREAS, the state disaster emergency related to COVID-19 has resulted in limited hours in municipal offices and rendered many seniors and individuals with disabilities homebound; and

WHEREAS, many seniors and individual with disabilities do not have the ability to file their real property tax exemption applications in person due to safety precautions and lack the ability to file such applications online; and

WHEREAS, Governor Cuomo has issued Executive Order 202.83, which grants local governments the ability to adopt a resolution extending the exemption status for those seniors and individuals with disabilities entitled to certain real property tax exemptions;

NOW, THEREFORE, BE IT

RESOLVED, that the Pompey Town Assessor shall extend the 2020 exemptions status for those individuals receiving the senior exemption and the person with disabilities and limited income exemption through 2021 without a renewal application except in the circumstances described below or unless a valid renewal form is filed with the assessor before the deadline of March 1; and be it

FURTHER RESOLVED that the Assessor may require a renewal application if he or she believes that an owner that qualified for the 2020 has since changed their primary residence, added another owner to the deed, transferred the property to a new owner, or is deceased.
